Terms & Conditions for Race to Sustainability!

1 Programme Details

- 1.1 The price of the programme stated <u>includes</u> 9% GST.
- 1.2 The fee(s) stated are subject to change without prior notice.
- 1.3 To allow each facilitated programme participant to receive the optimum experience from our on-site programmes, there is a cap on the maximum number of participants allowed per group. Each group is assigned one programme facilitator.
- 1.4 Programme fees are calculated based on the number of groups for the facilitated on-site programmes, or number of participants for the on-site competition event.
- 1.5 In the event that the number of participants per group is less than the stated capacity or there is a shortened duration, the full on-site programme fee will still apply.
- 1.6 Where the number of participants exceeds the group capacity on the day of the on-site facilitated programme, an additional group may be formed subject to the availability of programme facilitator(s) and programme materials and additional charges will apply. Please note that Gardens by the Bay is under no obligation to provide additional facilitators or relevant programme materials to cater to last minute additions.
- 1.7 Some activities are weather permitting. In the event of wet weather, Gardens by the Bay reserves the right to amend or replace the affected outdoor activities without prior notice at its sole and absolute discretion.

2 Registration, Payment and Confirmation

2.1 Registration, Booking Requests and Programme Reservation Form

a. Competition Event

- (i) Registration for the competition event must be made in writing by 11 October 2024, 5pm.
- (ii) Once registration for the competition event has been submitted to Gardens by the Bay, any request for amendments must be made in writing by <u>14 October 2024, 5pm</u> and is subject to the approval of Gardens by the Bay.

b. Facilitated Programme

- (i) Booking requests must be made in writing <u>at least 21 calendar days</u> in advance, from the date of the programme.
- (ii) The Programme Reservation Form must be submitted to Gardens by the Bay <u>at least 14</u> <u>calendar days</u> prior to the date of the programme.
- (iii) Once the Programme Reservation Form is submitted to Gardens by the Bay, any request for amendments must be made in writing and is subject to the approval of Gardens by the Bay.

2.2 Payment

- (i) Full payment must be made by <u>5 working days</u> before the date of visit for the onsite programme. Registration is confirmed only upon receipt of full payment and the issuance of an official Gardens by the Bay Programme Confirmation Form, from our Education officer.
- (ii) There will be no refund upon receipt of full payment.
- b. For schools paying via Vendors@Gov / IFAAS:
 - (i) Registration is confirmed only upon the issuance of an official Gardens by the Bay Programme Confirmation Form, from our Education officer.
 - (ii) Schools will be billed after the programme is completed. Please note that payment must be received <u>30 calendar days</u> from the invoice date.

2.3 **Programme Confirmation**

- a. No amendments may be made after the Programme Confirmation Form is issued.
- b. The Programme Confirmation Form must be brought along as proof of registration and/ or payment on the day of the programme.
- 2.4 There will be no refund should there be absentees on the day of the programme, or a postponement of the programme.

3 Cancellation/ No-show

3.1. The cancellation/ no-show policy is as follows:

Within 7 calendar days of the date of the programme as indicated on the Programme Reservation Form.	100% of total programme fee charged.

Gardens by the Bay will not bear any responsibility for travel expenses or any other costs which might have been incurred.

4 Punctuality

- 4.2 No extension of time will be allowed to compensate for the late start time.
